From the Area Chair...

It has been brought to my attention that full names and telephone numbers are being shown as contact information in Calendar entries on the NETA65.org web site.

I would urge you to discontinue this practice as it is contrary to our Anonymity Traditions. Also we need to consider the risk. Individuals and organizations (legitimate and illegitimate) harvest personal information from web pages for use by bulk mailers, telephone solicitors and search engine data bases (e.g. Google, Yahoo, Microsoft, etc.).

The NETA phone list has Area Committee members contact information and is sent to all Area Directory addressees by postal and/or email. The NETA65.org web site has a "Contact" page to email NETA Committee members. A mechanism exists to have the email automatically forwarded to an email address you specify for receipt of them.

During the months of November and December there will be a concerted effort to provide all the District Committee Members with spreadsheets containing Area Directory information for individual Districts. To the extent possible, the spreadsheet information will be distributed by email with a request that updated copies be returned by email.

It is now updated directly by the areas over the internet through an application called "Fellowship New Vision" (FNV).

In their latest letter on the subject, GSO has requested that all areas participating in the Fellowship New Vision updating of the GSO data base, to stop sending in hard copy forms to GSO. Instead please send the forms to the Area Record Keeper for processing. Currently, the Area Secretary serves as both Area Registrar and Area Record Keeper. There is one type of form and information, however that needs to be sent directly to Bill N, the Area Delegate. That information is for new groups. They get special handling between the Delegate and GSO.

He called me on the phone and then got into the subway; total cost, ten cents. At the level of the telephone booth and subway turnstile, spirituality and money began to mix. One without the other would have amounted to nothing at all. Right then and there, Ebby established the principle that A.A. in action calls for the sacrifice of much time and a little money."

The Titles below are the English Videos available for showing.

AA an Inside View -28 minutes – Depicts alcoholics recovering in A.A., going about their daily lives, and attending A.A. meetings and other gatherings.

Young People and A.A. – 28 minutes – Four young A.A. members describe what it was like drinking, what happened to bring them to A.A. and what their lives are like sober today.

It Sure Beats Sitting in a Cell – 17 minutes - Filmed inside correctional facilities in the U. S. and Canada. This video is about four young A.A.s who were in prison as a result of drinking, yet today are sober in A.A.

A.A. -- Rap With Us – 16 minutes – Features four anonymous young A.A. members. Rap music and lyrics bridge these four young people's stories of alcoholic despair and A.A. recovery.

Hope: Alcoholics Anonymous – 15 minutes – Explains the principles of A.A.: what A.A. is and isn't, primary purpose, sponsorship, home group, the Steps and Traditions, and basic recovery tools.

Bill Discusses the Twelve Traditions – 65 minutes – Bill W. tells how the principles safeguarding A.A. unity developed.

Bill's Own Story – 60 minutes – Co-founder Bill W. tells of his drinking and recovery.

You're A.A. General Service Office, the Grapevine, and the General Service Structure – 22 minutes – Tour the Grapevine office and your G.S.O., which also contains information on A.A.'s service structure.

Carrying the Message Behind These Walls – 15 minutes – Focuses on encouraging more A.A.s to participate in carrying the message into correctional facilities and addresses some of the concerns that hold members back from this rewarding service.

PSA Compilation Video – 10 minutes – Compilation video of all current PSA's, including the Spanish and French versions, for committee use.

Markings on the Journey – 35 minutes – Depicts A.A.'s history using rare material from A.A.'s archives.

Having been shown that there isn't any hierarchy or elite members in AA and grasping that ideal rather quickly was a good foundation for me. I also became aware with the near swiftness as I did with the no bosses that there are those who believe they know what is best for Alcoholics Anonymous with the same self-assurance I think the Titanic's Captain had with its unsinkability. If it sounds good or looks sound it must be.

These members believe they're doing the right thing for the right reason and they love the program. Then you find those with hidden agendas and egos to feed – poliitic behind the scenes.

Both are of the minority and though some would think a threat to our way of life this I don't think is the case. I see these members as a good motivation on top of the desire one already has to know what is and isn't AA principals, bringing the very best out in us as AA members. These few determined members ought to encourage us to be well informed. To trust in God to help us share on the Issues of importance, even if we take an unpopular stance. Remember always even with the most outspoken at our assemblies, or the eloquent orator who sounds so right to the majority, have to yield to the minority opinion at which time solid principals, AA history and years of AA experience can be presented to the Assembly's conscience for a motion to be reconsidered.

There are safeguards in Alcoholics Anonymous: Concept III – "Right of Decision", Concept IV – "Right of Appeal" (minority opinion). We use the Third Legacy Procedures in Area 65 for electing officers and for items of major importance require a two third majority to pass and should never be rushed – ever. I believe we would best be served if we stood in our Fifth Tradition's principal of our primary purpose, be well informed prior to any vote or decision or discussion, know the history of AA as well as the area history – so perhaps past errors may be avoided or that we don't duplicate services or policy unnecessarily. Also we might check our belief in the Second Tradition's principal: We have only one ultimate authority "... a loving God as He may express Himself ..." in an informed group conscience and to that our leaders are but trusted servants.

Area 65 has been and is extremely blessed because there is an abundance of good leaders founded in the love of God, AA principals, the fellowship and gratitude for the gift of recovery – that are capable and willing to serve given the chance. You know who they are, they are those who by action and example stand out as leaders – not through "self appointment". There is a strong presence in "Love and tolerance of others..." as is pointed out to us in Step Ten, page 84, of the Big Book, clearly it is stated that this "...is our code".

I'm grateful for being able to share my thoughts in the Area Newsletter. May God continue to bless Area 65. Also remember to enjoy yourself on your journey in Alcoholics Anonymous and the service you give back.
